### From the Editor - thoughts on postponement and uncertainty

Life has still not returned to any normality – or maybe this is the new normality for the foreseeable future. Nothing is the same and the result is uncertainty.


## Hospitaller activity 2019

*H.E. The Chevalier Prof. Charles Savona Ventura, Interim Grand Hospitaller, gives an overview of the philanthropic activities of the Order in 2019*

*“In response to the changing demands of the modern world, the various national jurisdictions have supported different philanthropic objectives “*

The wide vista presented by the ‘modern’ stated aims of the Order is reflected in the broad range of philanthropic activities supported by the various jurisdictions. The traditional link with the victims of leprosy has been maintained. However, in response to the changing demands of the modern world, the various national jurisdictions have supported different philanthropic objectives other than purely leprosy.

The philanthropic contribution of the International Order in 2019 amounted to an estimated total of just under €14,500,000. The larger part of the 2019 philanthropic contribution, amounting 85.2% of the total, has been targeted towards supporting palliative support and medical care of the needy members of society [aged and terminally ill]. The traditional support given to the victims of Hansen’s Disease only amounts to 2.7% of the total annual contribution [c.f. Figure 1].





Hansen’s Disease still remains a scourge in the developing world, despite the free-of-cost availability of the curative Multidrug Therapy regimen. Developing countries still see significant numbers of new cases being diagnosed annually. In addition, many prior victims of Hansen’s Disease remain marginalised and handicapped as a result of the chronic complications of the infection.

A particular area of concern in the developing world is childhood mortality generally brought about by malnutrition and gastrointestinal infections mainly caused by compromised water supplies. Only 2.5% of the total funds donated by the Order were directed towards promoting the care of children and their families; and most of these projects were directed towards the developed world rather than the developing countries. International activities, which include missionary support in developing countries, accounted for only 0.5% of the total philanthropic contributions of the Order.



The targets for philanthropic support provided by the Order appear to have rather placed the developing world on the backburner with a greater proportion of the donations being targeted to needy persons or communities in the developed world. 95.8% of donations targeted projects in Europe [93.4%], North America [1.2%] and Oceania [1.2%] [c.f. Figure 2]. The developing world accounted for about 4.3% of the total support provided during 2019. While the proportion of support appears low, this approximates to about €623,500. The philanthropic targets for this support vary but the larger part [2.7%] of the donation addressed victims of Hansen's Disease.



The philanthropic activities of the Order are left to the discretion of the National Jurisdictions who are better placed to identify worthy causes. As an international organization, the Order has introduced a donation of €5 per member per year to supplement the Philanthropic War Chest to support international worthy charitable causes. Unfortunately, not all national jurisdictions have embraced this initiative. This accumulated war chest should be used to assist a specific targeted project acceptable to all the jurisdictions. In the light of the general distribution of donations by the various jurisdictions and the global health and social needs, a suitable project to consider would be supporting an initiative to provide clean safe water to unprivileged communities in the developing world.

Many jurisdictions have developed resources to promote the education of health carers and social care providers aimed at providing better services to the needy. One such resource is that produced by the Grand Priory of Canada – *A Caregiver's Guide* – which is made freely available in electronic format to all. These resources should be advertised and shared.

The American politician Patrick Henry in 1799, stated: "Let us trust God, and our better judgment to set us right hereafter. United we stand, divided we fall."

### Archbishop Wilton Daniel Gregory EGCLJ

Archbishop Gregory, a long-standing member of the Order of St Lazarus, will be the first African-American Cardinal.

## In memoriam

We have been saddened to learn in recent weeks of the death of two well-known and much-loved members of our Order, both of whom had held senior international positions.

**Monsignor Anthony Toms EGCLJ KMLJ** passed away on 25 September 2020, aged 82. Tony, as he was universally known, was a well-known figure within the Order at home and abroad.



His clerical career took him from his home in Australia to Thailand and the USA, before returning home to become a military chaplain. From 1993 to 1996 Fr. Tony was Roman Catholic Principal Chaplain of the Australian Army and Vicar-General/Chancellor of the Military Diocese of Australia, achieving the field rank of Brigadier. In 1993 Pope St John Paul II made him a prelate of honour (Monsignor). Fr. Tony went back to civilian life in June 1996 when he became the Parish Priest at Seymour, Victoria – a post which he held until February 2016, when ill-health forced his retirement.

Tony joined the Order as a Chaplain (ChLJ) in 1995. He became a Deputy National Chaplain in 2003, going on to hold the post of Commandery Chaplain in Victoria for many years and was also Commandery President (2009-14). He

succeeded the late Archbishop Ian George AO CChLJ as National Chaplain of the Grand Priory of Australia in 2013 and retired in 2016. The Grand Master promoted Fr. Tony to Ecclesiastical Grand Cross (EGCLJ) in March 2014, citing his “extraordinary commitment” to the Order both in Australia and internationally.

**Chevalier Peter Gerrard Salt KCLJ, SCrLJ** passed to higher service on 16 October 2020 at the age of 71, after a long illness.

Peter joined the Order in 2008 as a founding member and first Chancellor of the Commandery of King Offa in the Grand Priory of England & Wales. In that position, he was an active, hard-working leader. Most notably, he chaired the working party charged with recommending a mission statement and formulating a strategic plan to take the Commandery forward, and forged close working relationships with the regional heads of Lepra, Debra and the Leprosy Mission.

In 2011 Peter became the Marshal of the Commandery and then Marshal of the Grand Priory of England and Wales. He was appointed Deputy Grand Marshal of the Order in 2016, and was also the International Quartermaster.

Peter was appointed KCLJ in February 2013. His recent reception into the Roman Catholic Church, with The Most Excellent The Duke of Seville as his godfather was, for him, a significant moment on his earthly pilgrimage.
